## Purpose of the Index

In order to equip it with a graphic presentation which would readily demonstrate any overlapping of function, inconsistencies in nomenclature and undesirable administrative patterns, the Legislative Council was directed by the Governor's Committee on Administrative Organization to prepare a chart showing the organization of state government on a functional basis. Such a chart has been prepared for the Committee and is now available to others, although in a limited supply, upon request. In order to further assist the Governor's Committee in its study of state government administration, there was prepared a list of the legal citations relating to the numerous offices, boards, and agencies appearing on the organizational chart. Thus, this listing takes the reader directly from the chart into the law authorizing each activity shown thereon and he can become more specifically informed regarding said activity. This index of laws, then, is intended as a supplement to the functional organizational chart of Colorado State Government.
