PROFESSOR CHRISTOPHER C. JOYNER

Regretfully, the biography of Professor Christopher C. Joyner was omitted from his article, Redressing Impunity for Human Rights Violations: The Universal Declaration and the Search for Accountability, published at 26 DENV. J. INT'L L. & POL'Y 591.

Christopher C. Joyner is Professor of International Law in the Government Department at Georgetown University, where he teaches courses on international law and organizations, U.S. foreign policy, and global environmental law. Formerly Professor of Political Science and International Affairs at George Washington University, Dr. Joyner has also held teaching positions at Dartmouth College, the University of Virginia, and Muhlenberg College.

Professor Joyner earned the Ph.D. degree in Foreign Affairs from the University of Virginia in 1977. He holds a B.A. degree in International Relations and two M.A. degrees (one in International Relations, the other in Government) from Florida State University.

Professor Joyner is presently on the Executive Council of the American Society of International Law, the Governing Council and Executive Committee of the Academic Council on the United Nations, and is the past Chair of the International Law Section of the International Studies Association. From 1989-1994, he served as Director of the ASIL's Project on the United Nations and the International Legal Order, sponsored by the Ford Foundation. Co-editor of UNITED NATIONS LEGAL ORDER (Cambridge University Press, 1995), he is also the editor of and contributor to THE UNITED NATIONS AND INTERNATIONAL LAW (Cambridge University Press, 1997).

Professor Joyner publishes extensively in international law journals on issues affecting the oceans, Antarctica, environmental law, the use of force, and international criminal law. Professor Joyner is the editor of REINING IN IMPUNITY FOR INTERNATIONAL CRIMES (1998), THE PERSIAN GULF WAR (1990), and THE ANTARCTIC LEGAL REGIME (1988). Professor Joyner has authored ANTARCTICA AND THE LAW OF THE SEA (1992), EAGLE OVER THE ICE: THE U.S. IN THE ANTARCTIC (with Ethel Theis, 1997), and TEACHING INTERNATIONAL LAW (with John King

Gamble, 1997). His most recent book is GOVERNING THE FROZEN COMMONS: THE ANTARCTIC REGIME AND ENVIRONMENTAL PROTECTION (1998), and he is now completing a volume entitled INTERNATIONAL LAW FOR THE 21ST CENTURY (Rowman & Littlefield, 2000).
