

ERRATUM

In the article by Robert B. Donin in the last issue of this journal, *Safety Regulation of the Concorde Supersonic Transport: Realistic Confinement of the National Environmental Policy Act*, the last sentence of the first paragraph on page 59 should read:

As applied to Concorde, this means that while the United States is free under Article 11 to apply its own regulations regarding, for example, fuel reserves, since this is a matter relating to the "admission or departure" of the airplane, it is severely circumscribed by Article 33 in the extent to which it may examine, for example, the adequacy of Concorde's system for fuel tank fire suppression since that is an "airworthiness" matter as to which the United States is obligated to accept the assurance of the British and French aviation authorities.⁴⁸
