The long standing nature of the Palestinian-Israeli conflict, coupled with a belief that abatement is not in the offing, lends itself well to scholarly attention and legal discernment. Collectively the materials presented offer those who deal with this sensitive and delicate set of human relationships an opportunity to think about the issues rather than search for comments written by others.

As with any bibliography, even those considered to be comprehensive, some citations have not been included, but not intentionally excluded. Many of the citations are several years old; this has resulted from picking up what had not been compiled previously. In such subsection, books and monographs are listed first, followed by periodicals and unpublished materials.

GENERAL BACKGROUND

III. THE UNITED NATIONS AND THE CONFLICT

When dealing with the United Nations, an obvious source of information is original U.N. documentation. Essential reference materials

would include *United Nations Document Index* (UNDOC), *United Nations Cumulative Index*, *United Nations Official Records*, *United Nations Chronicle* (formerly *United Nations Monthly Chronicle*), *United Nations Publications*, and the *Yearbook of the United Nations*, all published by the United Nations. Other useful finding tools are Landskron and Hufner & Naumann:
