## BOOKS RECEIVED

**CASES ON CRIMINAL LAW.** By J. W. Cecil Turner and A. LL. Armitage. New York: Cambridge University Press. 1964. xiv + 664 pages. Cloth: \$12.00. Paper: \$4.95. The third edition of a well established English casebook, this is the first of the new Cambridge Legal Case Book series.

**CRIME AND PERSONALITY.** By H. J. Eysenck. Boston: Houghton Mifflin Co. 1964. xv + 204 pages. \$4.50. A psychologist's look at criminal behavior with emphasis on heredity and conditioning as major causative factors. The author cites numerous experiments in suggesting some causes and cures for delinquent individuals.

**DISINHERITED AND THE LAW, THE.** By Dagobert D. Runes. New York: Philosophical Library. 1964. vii + 79 pages. \$3.00. The author demonstrates that the law is not a symbol of justice, but rather an expression of the wishes and desires of those in dominance.

**ELECTORAL COLLEGE, THE.** By Lucius Wilmerding, Jr. Boston: Beacon Press. 1964. xiii + 224 pages. \$1.95. The author considers the difficulties inherent in the existing method of electing a President and examines three current proposals for its reform: the district system, national plebiscite, and proportional voting.

**HOW HIGH IS UP.** By David Loth and Morris L. Ernst. Indianapolis: Bobbs-Merrill Co. 1964. 276 pages. \$4.50. A book seeking to explain to laymen how legal concepts are adapted by courts to accommodate progress in society.

**LAWYERS IN POLITICS.** By Heinz Eulau and John D. Sprague. Indianapolis: Bobbs-Merrill Co. 1964. 164 pages. \$5.00. A study in professional convergence.

**MANAGING THE LAW OFFICE.** Daniel J. Cantor, Editor. Mundelein, Ill.: Callaghan and Co. 1964. xii + 296 pages. \$18.50. A collection of essays on law office economics and management.

**NEW MEANING OF TREASON, THE.** By Rebecca West. New York: The Viking Press. 1964. viii + 374 pages. \$6.95. The author has revised and expanded her classic work on traitors and defectors of World War II to include cases from the 1950s and 1960s.

**PUBLIC AND ITS GOVERNMENT, THE.** By Felix Frankfurter. Boston: Beacon Press. 1964. 170 pages. \$1.95. A new edition of Mr. Justice Frankfurter's small work, written in 1930, expressing his views on the responsibilities of citizenship and the relationships between law, government, and society.

**RIGHT OF ESTABLISHMENT IN THE COMMON MARKET, THE.** By Ulrich Everling. Chicago: Commerce Clearing House. 1964. xv + 219 pages. \$15.00. A comprehensive description of the right of establishment in the European Economic Community presented against the background of current political, legal, and economic conditions.

**TREASURY OF LAW.** Richard W. Nice, Editor. New York: Philosophical Library. 1964. xii + 553 pages. \$10.00. A representative assemblage of many of the meaningful and significant documents that, throughout history, have contributed to man's determination to govern his conduct in inter-personal and international affairs.
