Bar Integration

We present in this issue a very interesting article on Bar Integration by Frederick W. C. Webb of the Maryland bar. Whether or not you have at the present time a definite opinion regarding Bar Integration, we feel that you will enjoy Mr. Webb's presentation of this subject. In the article Mr. Webb refers to the status of the question of integration in Massachusetts. Subsequent to the writing of this article the proposed rules and by-laws of the integrated Massachusetts bar have been drafted and circulated among the members of the Massachusetts bar with request that comments and suggestions be reported to the committee of 25 before that committee reports at the next Massachusetts Lawyers' Institute to be held in June, 1946.

New Rules of Criminal Procedure

The new rules of criminal procedure in federal courts go into effect on March 21, 1945, three months after the adjournment of the first regular session of the 79th Congress. When these rules go into effect the entire field of procedure in the federal courts will be regulated by rules promulgated by the supreme court. There will also be brought into the federal courts uniformity of procedure in criminal cases. The adoption of the rules of criminal procedure, following within a short time the adoption of the rules of civil procedure, mark a distinct advance in the field of improvement in judicial administration. Arthur T. Vanderbilt, former President of American Bar Association and of the American Judicature Society, is one of America's outstanding leaders in the field of judicial improvement. He and his committee are to be congratulated for this notable advance.

Admitted to a Higher Court

James E. Garrigues, Denver, former chief justice of the Colorado Supreme Court, recently passed away at his home after a long illness. He was 93 years of age. During his earlier years Judge Garrigues was a resident of Greeley. He moved to Denver in 1911 when he was elected to the Supreme Court, where he served until 1921. Upon his retirement from the Supreme Court he served as assistant district attorney in Denver, and then entered private practice. He served as district attorney in the Eighth Judicial District and judge of the district court before his election to the Supreme Court.

Henry Howard, Denver, died recently after a short illness at the age of 80. Mr. Howard came to Denver in 1889 and practiced law here for over fifty years. He was born in Nashville, Tennessee, spent his boyhood in Iowa and was graduated from the Iowa City law school.

Thomas H. Hood, widely known Denver attorney, died recently at the age of 90 years. Mr. Hood came to Denver from Chicago before 1900 and had maintained offices in the Equitable Bldg. for forty-five years.

Our Returning Lawyer-Veterans

Gordon L. Allott, capt., Air Corps, served from Aug. 1942 to Mar. 1946 in the South Pacific, Southwest Pacific and Philippines. He received eight battle stars and the Presidential Unit Citation. He has re-opened an office for the practice of law at 120½ South Main Street, Lamar.

Jerry S. Williams, capt., Air Corps, Air Transport Command, served from Oct. 1942 to Mar. 1946 in the Caribbean, Florida, Puerto Rico, Cuba, Trinidad and British Guiana. He has joined the faculty of the Law School of the University of Denver as assistant professor of law in the field of public law.

John Donovan Stapp, lt. comdr., USNR, Air Combat Intelligence, served from June 1942 to Jan. 1946 in West Africa, Brazil, Australia, Morotai, Philippines, China and India. He received the Bronze Star. He served on a special liaison mission in China and India in 1945. In 1944 he participated in a special lecture tour of all Brazilian bases. He is now practicing law at 313 First National Bank Bldg., Denver, and is possibly interested in a connection with an established firm. He was admitted to the Colorado bar in 1935. He has the degree of A.B. from the University of Colorado in 1933 and the LL.B. from same in 1935. Before entering the service he had seven years general private practice and was vice-president and general counsel of the Denver Joint Stock Land Bank.

Charles Henry (Hook) Anderson, seaman first class, Navy, served from May 1944 to Nov. 1945 in the South Pacific area. He and Leonard E. Anderson have associated for the practice of law under the firm name of Anderson and Anderson, with offices in the First National Bank Bldg., Fort Morgan, for Charles Henry Anderson and in Brush for Leonard E. Anderson. Charles Henry Anderson was for several years before entering the service Assistant Attorney General of Colorado.

Thomas C. Chapin, major, Corps of Engineers, served from Nov. 1940 to Mar. 1946 in the United States and in England, France and Germany. He received the Bronze Star Medal. He has not yet located in practice and is looking for office space or other connections. He was admitted to the Colorado bar in February 1939. He has the degree of Ph.B. from Yale University in 1931, LL.B. from Colorado University in 1937, and the LL.M. from Columbia University in 1939. He was in general practice from February to December 1939, and was associated with Bannister and Bannister from January to November 1940.

Lawrence M. Henry, major, Chemical Warfare, served from May 1942 to April 1946 in England. He was awarded the British decoration "Member of British Empire." He has been appointed chief deputy clerk of the Denver County Court. Mr. Henry was the youngest member of the 33rd General Assembly (1941), before he entered service. While serving in London in the British War Office to make local procurements under reverse lend-lease, he met and married Mary Jane Kelly, then serving in the American embassy, daughter of the late congressman Clyde Kelly of Pittsburgh.
